

## **Brief Descriptions of Workshops**

## Research Strategies, Publication and Education Development



Speaker
Professor Joshua Ka Ho Mok
Vice President and
Chair Professor of Comparative Policy,
Lingnan University

Professor Mok is the Vice President and concurrently Chair Professor of Comparative Policy of Lingnan University. Before joining Lingnan, he was the Vice President (Research and Development) and Chair Professor of Comparative Policy of The Hong Kong Institute of Education, and the Associate Dean and Professor of Social Policy, Faculty of Social Sciences of The University of Hong Kong. Prior to this, Professor Mok was appointed as the Founding Chair Professor in East Asian Studies and established the Centre for East Asian Studies at the University of Bristol, the United Kingdom.

The workshop provides a platform for academics and postgraduate students for discussing major issues and challenges for getting their research published in internationally referred venues. Making reference to the international journals and book series that Mok has edited for Routledge and Springer, two major international publishers, the workshop will highlight some practical aspects for postgraduates and young academics for international publication. Meanwhile, the workshop also sets out to explore the possibility to develop research clusters for promoting research collaboration along the conference themes.

## Analysing National Statistical Data: Methodological Issues



## **Speaker**Professor Hon Kwong Lui

Department of Marketing and International Business, Lingnan University

Professor Lui received his Ph.D. in Economics from The University of Hong Kong and is now Professor and Head of the Department of Marketing and International Business in Lingnan University. He worked for a few years as marketing executive in retail industry and as Statistician in the civil service before joining the University. His consulting experience is mainly in the area of market research and analysis and his research interests include labour economics, applied marketing research, and Hong Kong economy.

With the advancement of information technology, national statistical databases are widely available in the internet. In April 1996, the International Monetary Fund (IMF) established the Special Data Dissemination Standard (SDDR) to guide member countries in the dissemination of national statistics to the public. The subsequent SDDR Plus clearly specifies the monitorable elements in respect of access, integrity, and quality emphasizes transparency in the compilation and dissemination of statistics. This major move made international comparative studies much easier. However, researchers should note that international acceptable statistical methodologies do allow certain degree of flexibility which makes international comparison NOT as straightforward as one would expect. This workshop discusses the methodological issues of analysing national statistical data with special reference to Hong Kong and International statistical databases.

## Mixing Methodologies in Comparative Research

Dr Stefan Kühner

Dr Kühner's academic interest centres on comparative and international political economy with emphasis on the policies and politics of productive and protective dimensions of welfare in historical perspective. Utilising fuzzy set ideal type and qualitative comparative analysis, Dr Stefan Kühner discussed the notion of welfare productivism as conceptual backdrop for comparing recent social policy reforms across in Europe and East Asia. Most recently, he has been involved in research examining the impact of family cash benefits and services on child well-being and discussing inequality in child well-being in EU/OECD countries.

Advances in international macro-level data consolidation offer an enticing opportunity to revisit contested conclusions in comparative research. Building on a summary of the rationale for mixed methods research designs and different varieties of mixed methods, this workshop will explore the ways in which pooled time-series cross-section (TSCS) regression specifications can sensibly be combined with fuzzy set analysis to identify typical and deviant cases in medium and large-N comparative research. More specifically, using the empirical example of recent debates on the effect of inequality and redistribution on economic growth spells in Asia, the workshop will demonstrate the strengths of 'mixing it up' rather than focusing on epistemological and ontological divisions between these two research techniques.

## Qualitative Longitudinal Methods

Dr Aniela Wenham

Dr Wenham's area of expertise is qualitative longitudinal research with young mothers. She is the associate editor of the Journal of Youth and Policy and has been involved with this organisation over a number of years, delivering key note speeches on teenage pregnancy and motherhood, and working with the organisation in order to bring together practitioners and academics that share an interest in the issues young people face. Within the Department of Health Sciences, Dr Wenham has also been involved in a project titled: 'Adult Siblings of People with Autism and High Support Needs: their experiences, perspectives & future support needs'. Her current working project is 'Problem drug users and drinkers in hospital: staff-patient interactions and perspectives'.

This workshop will explore the recent interest in examining the interface between biography and social policy. More particularly, it examines the value of qualitative longitudinal methods, its use in a number of research projects within the Department of Social Policy and Social Work (University of York, UK) and its potential within the field of comparative research. The theoretical frameworks, principles and processes of conducting qualitative longitudinal methods will be introduced. In the second half of the workshop, Dr Wenham will discuss her longitudinal research with teenage mothers (Wenham, 2015). Workshop participants will be asked to consider how qualitative longitudinal research aligns to their own research interests and what ethical dilemmas might arise when conducting this methodology.

## Crafting Comparative Historical Case Study Analysis

Dr Antonios Roumpakis

Dr Roumpakis holds an undergraduate degree in Sociology (University of Crete) and a PhD in Social and Policy Sciences (University of Bath). Before joining the University of York, he taught at the Department of Social and Policy Sciences (Bath) and he also spent a year as a post-doctoral researcher at the Nordic Centre of Excellence in Welfare Research (NORDwel) at the University of Helsinki.

The workshop discusses the advancements of comparative historical methods and the available strategies for causal assessment among small-N cases. It will review key comparative research strategies for establishing comparative historical analysis (CHA). Then we aim to identify different levels of aggregation and how within-case analysis (WCA) can be utilised to explore causal processes that are associated with timing and sequence. The workshop will aim to bridge these approaches to demonstrate how both CHA and WCA can brought together to test theoretical hypotheses, identify similarities and differences, and establish causal explanations. The workshop will highlight that bridging these two approaches necessitates to address key challenges such as the relationship between theory and methods; the importance of the context for the operationalisation of variables; data selection; levels of analysis; levels of aggregation; capturing timing, time and sequence; and finally the triptych of 'agency, structure, ideas'. Participants will be asked to reflect on aspects of their research design, strategies and research experience.

## The Challenges of Comparing Child Well-Being across Countries: Reflecting on the UNICEF Report Card 13 Research Experience

## Professor John Hudson

Department of Social Policy and Social Work, University of York, UK

Professor Hudson has worked at the University of York since 1998. He was Head of Social Policy/Deputy Head of Social Policy & Social Work from 2009-2014 and is currently the Co-Director of the Centre for Research in Comparative and Global Social Policy with in the Department of Social Policy & Social Work. He specializes in comparative analysis of the politics of social policy. His most recent publication in UNICEF's Report Card Fairness for Children (co-authored with Stefan Kühner) is released on 14th April.

International organisations have increasingly focused on comparing countries using multi-dimensional measures of child well-being in order to evaluate the living condition of children and young people. Drawing on the most recent UNICEF child well-being Report Card (*Fairness for Children*), co-authored by John Hudson and Stefan Kühner, this session explores the challenges of comparing child well-being across countries. It explores key conceptual and methodological debates, including which dimensions to examine, which measures and how different indicators can best be combined. In so doing, it asks whether the focus of comparative child well-being studies ought to be on the outcomes of the average child or the most vulnerable children. It reflects on what lessons can be drawn from comparative analyses for social policy in East Asia and asks whether some countries provide a model example in terms of providing a fair to start to life for children.
